## TERMS AND CONDITIONS FOR GRAND VIN DE STELLENBOSCH NECKTAG PROMOTION

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry and claim instructions are deemed to form part of the terms and conditions and by participating, all entrants will be deemed to have accepted and be bound by the terms and conditions. ### **Eligibility:**

1. The Promotion is open to residents of Great Britain (England, Scotland and Wales), The Netherlands, Poland, Hungary, The Czech Republic and Slovakia aged 24 and over, excluding employees or agencies of Origin Wine ("OW", "We") its group companies or their family members, or anyone else connected with the Promotion.

### **Promotional Period:**

2. Entry for the Promotion opens 1 August 2018. The closing date for entries is 30 January 2019. Entries received outside this time period will not be considered.

### **How to enter:**

3. To enter the Weekly Prize draw you must purchase a 750ml bottle of Grand Vin de Stellenbosch wine with a promotional neck tag from a participating retailer, go to <http://www.granddomaine.co.za> and enter your name, email address and the unique number from the back of your promotional neck tag. **Please retain neck collar and receipt – these may be required to verify winning claims.**

4. Maximum one entry per person, per week. Unique numbers may only be used once.

5. All entries to the weekly prize draw will also be entered into the Grand Prize draw. You can also enter the Grand Prize Draw without making a purchase by registering via the Grand Prize draw entry page (maximum one entry per person via this route).

6. OW accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt.

### **Prizes:**

7. There are 27 weekly Prizes to be won, supplied at the Promoter's discretion.

8. There is 1 Grand Prize of "A trip for two to South Africa" which consists of economy fare flights and 5 days and nights' accommodation at Le Jardin Villa in Stellenbosch. Two meals per day, all transfers and transport will be arranged. Winners will have the opportunity to visit the cellar and taste the wines from the tanks.

**Winner selection:**

10. weekly Draw: One winner will be chosen at per week from all entries received by 23.59 of the Sunday of that week, in accordance with these Terms and Conditions. The draw will be performed by a random computer process. The draw will take place weekly from 1 August 2018 to 30 January 2019. Non-winning entries will be rolled over to the next draw.

Grand Prize Draw: One winner will be chosen from all entries received in accordance with these Terms and Conditions within 28 days of the final closing date and announced within 6 months of the closing date. The draw will be performed by a random computer process. weekly Draw Winners will be included in the Grand Prize Draw.

**Winner Notification:**
